A food systems approach is needed to achieve SDGs




Importance of territorial approaches to contribute rural transformations towards SDGs


- 1. <u>IDENTIFICATION</u>: be sure about your potentialities and join forces!

- 5. ROLES OF PUBLIC ACTORS














Evaluating GI: a variety of needs

- Well establish the rules according to the objectives
- Demonstrate effectiveness to users and supporters
 - Voluntary approach: producer engaging or staying if it is worthy
 - Public good, public investment, reporting to society
 - Many "sleeping GIs"
- Evolve to adapt issues and changes
 - Long term investment: many changes along the road: initial objectives, economic and political context, people, climate change...
 - **→** review objectives, specifications, strategy
- Contemplate a variety of effects in a systematic way
 - different spheres (economic, social, environmental) and levels (firm, group, VC, territory)
- Ensure more sustainable GI systems: "assess to improve"
 - Political: agenda 2030, EU policy
 - Economical: market access, reputation, sustainability reporting, reproduction of local resources
 - Self esteem





Why such a guide for local actors?

For local actors:

- GI initiatives are rooted in the territory and linked to local public goods: Local public and private actors are concernedhave the resurces to invest/contribute
- Capacities of local stakeholders to find their own solutions

Practical guide:

- Complexity of GI evaluation
- Lack of producers awareness and capacities
- methodologies for shared and informed decision-making, in particular about Trade-offs

For tailored evaluation framework

 GI specificity needs case by case approach (diversity, link to cultural and natural dimensions, tailored specifications related to specific objectives)

Through participatory approach

- Inclusiveness and external inputs
 - Producers and VC
 - Local authorities
 - Academic





Practical objectives



- **Build capacities** on evaluation, monitoring, managing participatory process; facilitate development and management of a territorial strategy
- Ensure adequacy of the GI system to local situation, context and users objectives; helping understand
 the connections and trade-offs between economic, social and environmental, ensuring tailored
 specification
- Strengthen local governance and multi-stakeholder approach and structures (GI asso, inter-branch, public-private...)
- Strengthen public-private coordination and partnerships with sponsors or other stakeholders
- Boost the credibility and visibility of a GI initiative


Prospective

- Understand what can be the effects of GI initiative;
- Identify the most important issues to be tackled
- identify and leverage the strengths of a GI initiative
- Define the common rules in a participatory way, discussing pros and cons.

Retrospective

- Understand what are the effects of the GI initiative
- Understand if the objectives have been met
- Analyse the causes of failures and successes
- Determine how the GI initiative can be changed to better reach its aims.
- Demonstrate and monitor GI impacts
