



## VI. Executive board

The Executive Board is the governing body of the association, responsible for directing its activities and making decisions between General Assemblies. It consists of three key roles: Presidency, Vice-Presidency, and Treasury. The members of the Executive Board are elected every three years by AREPO members. The current mandate runs from **October 2021 to October 2024**.

### 1. Presidency

The Presidency is elected every three years by AREPO member regions. In October 2021, the Region of Extremadura was elected to hold the Presidency, represented by **Ms Begoña García Bernal**, Regional Minister for Agriculture, Rural Development, Population and Territory of Extremadura.

On June 14th 2023, following the regional elections in Spain, the regional government of Extremadura Region changed and Ms Begoña García Bernal resigned from her role as Regional Minister of Agriculture, thus resulting in **the end of her mandate as President of AREPO**.

As indicated in AREPO Statutes, the vacancy was briefly covered by **the Treasurer, Ms Patricia Picard**, until the new Regional Minister of Agriculture of Extremadura Region was appointed

In August 2023, **Ms Mercedes Morán Álvarez** was appointed by the new Regional Government of Extremadura as **Regional Minister for Agriculture, Livestock and Sustainable Development** and took over as **President of AREPO**.

### 2. Vice-Presidency

The Treasurer is elected by the General Assembly. Currently, this role is performed by the Region of Auvergne-Rhône-Alpes. The Treasurer is **Ms. Patricia Picard**, **Regional Councillor of Auvergne-Rhône-Alpes**.

The process of **revision of the EU quality schemes ended with the entry into force of the [new regulation on 13 May 2024](#)**, after years of tireless work for AREPO to protect and strengthen EU Geographical Indication system.

## ► Overview on AREPO joint achievements

The AREPO technical working group dedicated its efforts to crafting 50 amendments for the GI revision. Notably, these proposed changes found **substantial recognition** as COMAGRI rapporteur **De Castro incorporated 24 of them into his report**, with an additional 32 out of his 122 amendments reflecting the influence of AREPO's suggestions.

Following the De Castro report presentation, AREPO continued its active role by introducing more amendments in November 2022. These subsequent proposals, well-received within the European Parliament's Committee for Agriculture and Rural Development (Agri Committee) through support from various MEPs, signify a continued and collaborative effort to shape the GI revision.

Furthermore, **AREPO's engagement as an expert in shaping the Committee of the Regions' Opinion** on the GI revision has been **instrumental** in extending the reach and impact of its actions.

## Achievements

- The creation of a **single regulation** covering agricultural products and foodstuffs, wines and spirit drinks, while maintaining some specific provisions on wine in the CMO regulation;
- **Faster procedures** for registration and amendments;
- **Strengthening the role of producer groups** and introducing more powers and responsibilities for recognised producer groups. The agreement maintains the provisions on recognized producer group already existing in some Member States, making it optional for other Member States to establish a recognition system;
- **Improving GIs protection**, especially **online** and on **domain names**. This will be enforced using geo-blocking and will be aligned with the Digital Services Act;
- Extension of **protection to GIs used as ingredients**. To use a GI name when it is an ingredient in other products, processors are required to inform the relevant producer group in advance and it is now mandatory for them to indicate on the label the percentage of GI product used. Those Member States that wish to do so may also provide for a requirement of written authorisation by the producer group;
- The **recognition of GIs commitment towards sustainability**. To better valorise GI producers' actions regarding economic, environmental and social sustainability, GI producers can agree on sustainability practices, that can be voluntarily showcased in a sustainability report or included in the product specification. Furthermore, the text agreed upon by co-legislators introduces a non-exhaustive list of sustainability practices, as requested by AREPO;
- The **central role of DG Agri** in the management of the GI system, supported by the European Union Intellectual Property Office (EUIPO) on administrative issues.

## II. Farm to Fork strategy



### ► Sustainable food system framework

A legislative proposal for a framework for sustainable food systems (SFS) **was supposed to be published by the end of 2023**. However, due to delays, **it hasn't been published during the previous EU legislature (2019-2024)**.

The SFS framework was intended to be one of the flagship initiatives of the Farm to Fork Strategy with the aim to accelerate and make the transition to sustainable food systems easier, promote policy coherence at EU and national level, mainstream sustainability in all food-related policies and strengthen the resilience of food systems. It should have also included a sustainable food labelling framework.

Here's a list of **key recommendations** presented in [AREPO's position](#) on the topic:

- Urge the SFSF to acknowledge and highlight the existing contribution of GIs to the transition towards a sustainable food system.
- Advocate for the SFSF to support ongoing sustainability efforts of GI producers through a voluntary approach, recognising sustainability as a continuous improvement process that should be encouraged and accompanied.
- Recommend a holistic and multidimensional approach to defining a sustainable food system, encompassing all three pillars of sustainability, including economic and sociocultural aspects, beyond health or nutrition considerations.
- Call for coherence and consistency with other F2F initiatives.
- Advocate for a just transition by supporting costs incurred by producers transitioning to more sustainable models with adequate accompanying measures, with a priority for small producers.

- 12 May 2023 – [Joint letter to Commissioners Kyriakides, Wojciechowski, and Sinkevičius](#) on the need for an increased dialogue with united EU food chain to ensure a robust and enforceable Framework Legislation on SFS.
- May 2023 - **Working group with other agri-food organisations**, coordinate by COPA-COGECA, for defining common principles for FSFS. The group elaborated a **working document** shared for feedback with AREPO members.
- 15 June 2023 – [Joint Letter to Commissioner Kyriakides, Commissioner Wojciechowski, Commissioner Sinkevičius](#) Presenting a **common proposal** shared by several EU agri-food organisations on **basic principles** for the Framework on Sustainable Food Systems (FSFS)



### ► Front-of-pack nutrition labelling (FOPNL)

The proposal to review the rules on food information for consumers, including a new Front-of-pack-nutrition labelling system, was supposed to come out in early 2023. However, due to delays, **it hasn't been published** during the previous EU legislature (2019-2024).

The core messages presented in [AREPO's position](#) on this topic recommend:

- **Attention concerning the Impact on EU Quality Schemes:** AREPO voiced concern that proposed actions for FOPNL may harm EU GI products.
- **Caution Against Oversimplified Nutrition Information:** we opposed an oversimplified FOPNL system, like Nutriscore, as it may misrepresent information and negatively affect products like GIs.
- **Emphasis on Nutrition Education:** we emphasised the need for education and communication on balanced diets, advocating for a focus on consumer understanding of the role of GIs and quality products.
- **Alternative Communication for EU GIs:** If mandatory FOPNL were to be implemented, AREPO suggested alternative communication strategies for EU GIs, including budget allocation for promotion and increased scientific research.



### Achievements

The **European Commission** publicly declared that is not going to propose the **Nutri-score** as the new EU-wide food labelling scheme.

Even if the EC didn't exclude that the future labelling system could be a 'traffic light' label, at least it will not be the Nutri-score as it is now.

In fact, the EC recognised that there is room for improvements, concerning the elements to be included, and that it can be adapted to the findings and criticisms of recent scientific opinions (e.g. opinion provided by EFSA: Nutri-score does not ensure correct and complete information to consumers).

### III. Promotion policy

AREPO regularly participates in the Civil Dialogue Group of DG AGRI on promotion, as well as in the **Infoday on the promotion programme** ([click here](#) to see the presentations of the 2024 virtual event), in order to update its members.



Moreover, every year AREPO updates and shares with members the descriptive note on promotion policy. Find [here](#) the **note on 2024 calls for proposal** presenting priorities and calls from the work programme of promotion policy for 2024.

AREPO also presented [its inputs for the 2025 Annual work programme](#). Following the news of a drastic cut to the Promotion budget for 2025 (only €92 million entirely dedicated to simple programmes, with €0 allocated to the multi programmes and the EC own-initiatives), together with other 18 European agri-food sector organisations, we sent a joint [letter to the EU Ministers of Agriculture](#) and to the [Agricultural Permanent Representatives to the European Union](#), to express the concerns of the sector and urge the Commission to support the continuation of an inclusive Promotion policy and to restore the previous budget.

AREPO also continued monitoring the process of **revision of EU Promotion Policy** ([click here](#) to consult the position submitted to the related public consultation). The legislative proposal was expected to be published in June 2022. However, due to delays, **it hasn't been published during the previous EU legislature (2019-2024)**.



In January 2023, **AREPO** and other 16 organisations representing the agro-food sector **sent a joint letter to Mr Frans Timmermans**, Executive Vice-President of the European Commission, **and Mr Janusz Wojciechowski**, Commissioner for Agriculture. The letter expressed stakeholder **concerns over the delay in the publication** of the EC proposal on the revision of EU Promotion Policy.

The core message presented in AREPO's position on this topic recommend an **inclusive approach that does not discriminate** against any type of EU agricultural product or sector and includes red and processed meat and alcohol drinks in the list of products eligible for funding.



**This position was reiterated** in a [joint letter](#) sent to the Agricultural Permanent Representatives to the EU in October 2023, ahead of the meeting of the committee for Common Organisation of Agricultural Markets, to present agri-food sector's views on the 2024 Annual Work Programme.

## IV. Common Agricultural Policy (CAP)



European Commission President Ursula Von der Leyen announced during her annual State of the Union speech on September 13<sup>th</sup>, 2023, the launching of a "[strategic dialogue](#)" on the [future of agriculture in the EU](#), aimed at reducing polarisation in the agri-food policy debate. This dialogue, promoted at the EU Agri-Food days on December 6<sup>th</sup>, 2023, began in January 2024. 30 stakeholders from diverse sectors of the agri-food

industry were invited to address key questions such as improving perspectives for farmers and rural areas, supporting sustainable agriculture, leveraging knowledge and innovation, and promoting a thriving future for Europe's food system.

Alongside the Strategic Dialogue, the Commission has organised a series of [5 technical workshops](#) through which it consulted Member States' experts and key stakeholders represented within the Civil Dialogue Group on CAP Strategic Plans, to identify challenges and to assess needs in agriculture with a view to gather input for future policy developments, particularly the future CAP whose proposal should be ready in Autumn 2025.

The workshops were focused on five topics: **Resilience; Food Security; Sustainability; Solidarity and Rural Area; Governance and performance.**



As a member of the DG AGRI Civil Dialogue Groupe on CAP strategic plans, **AREPO participated in all this workshops' cycle** that started in December 2023 and finished in April 2024.

## V. Geographical Indications for craft and industrial product

For several years AREPO has been following the developments at EU level in the field of non-agricultural GIs, calling for their recognition and laying stress on the importance for all GIs to be protected. In this framework, AREPO has been collaborating with the **French Federation of Industrial and Artisanal Geographical Indications (FFIGIA)**, by supporting the setting of a lobbying strategy at EU level to put forward the demands of the sector in front of EU Institutions. This cooperation was further consolidated through a partnership agreement, [making FFIGIA one of AREPO associated members](#).



The European Commission published the [legislative proposal](#) on 13 April 2022 to address the lack of a common EU legal framework for non-agricultural GIs. We monitored actively the development of the legislative process, **aligning our efforts with the work undertaken by FFIGIA** and providing updated information and detailed analysis to our member Regions and producers ([Click here](#) to read AREPO analysis).

Following an informal interinstitutional agreement reached in Spring 2023, the European Parliament and the Council approved the **new Regulation (EU) 2023/2411, published in the EU Official Journal** on 27 October 2023. The new regulation entered into force on 16 November 2023 and it is expected **to be fully applicable by 1 December 2025**, two years after its publication.

The new regulation builds upon the existing GI system for agricultural products, but it is **tailored to the specificities of craft and industrial products**.



### Key points

- ➔ It covers **PGI** which may be labelled, on a **voluntary** basis, with the **same EU logo** currently used for EU agri-food PGIs.
- ➔ It foresees a **two-step registration process**, involving the national level and then the EU level through EUIPO.
- ➔ **National authorities will perform controls** and make sure products respect their specifications.
- ➔ It includes **robust protection rules**, mirroring those existing for agricultural GIs.
- ➔ It will grant non-agri GIs **protection under EU trade agreements**.

## VI. Organic Farming

AREPO monitored the developments related to organic farming. After being postponed, **the new organic regulation** entered into force on 1 January 2022.

AREPO policy officers have been chosen by the Committee of the Regions (CoR) as **experts** to support the CoR rapporteur, Mr Uroš Brežan, Mayor of Tolmin (currently Minister for environment and space of the Republic of Slovenia), in the drafting of its [opinion on the EU action plan for organic farming](#), which was adopted by the Plenary session of the CoR on 2 December 2021.

## VII. Regulation on packaging and packaging waste



In November 2022, the European Commission published [its proposal for a new Regulation on packaging and packaging waste](#), to replace the existing framework established in 1994. Its main aim is to foster circularity and eco-friendly packaging, addressing the whole life-cycle of packing, and to set ambitious targets for companies and Member States to reduce waste and enhance recyclability. Especially, **it requires all packaging placed on the market to be recyclable by 2030**.

AREPO monitored the legislative process since the regulation took into account an **exemption for GIs concerning packaging performance criteria**, particularly at **Whereas 40 and Article 9.2**.

Ahead of the beginning of the interinstitutional trilogues, in December 2023, AREPO and AREFLH alerted the Environment Permanent Representatives to the EU (click [here](#) to read the joint letter), on the need to grant an explicit **exemption for PDO and PGI fruits and vegetables** from the banning of single-use packaging for fruit and vegetables weighing less than 1.5 kg.

This exemption for quality schemes is necessary because of the need to provide consumers with the compulsory information on certification and the logo. Moreover, the absence of this information on packaging would increase the risk of deliberate fraud or clumsy communication about the true origins and quality of labelled products.

## VIII. EU trade policy

AREPO usually monitors EU Trade Policy as concerns the trade agreements signed between the EU and third countries. Its approach focuses especially on the **chapter dedicated to the list of GIs protected through the trade deal**.

Furthermore, AREPO has been invited to join and become a founding member of the **China-European Geographical Indications Development Alliance (GIDA)**, a platform aiming to foster collaboration between China and Europe in the recognition and protection of GIs.

## Working groups

- Members often request to set up **technical working groups on specific topics**, directly or indirectly related to quality schemes and product of origin.
- AREPO usually takes care of the **logistic organisation of the meeting and contribute to the exchange with its expertise on EU policies and legislative processes**, as well as any other developments at EU level.
- The region which proposed the topic is asked **to animate and moderate the group**, so that the agenda setting follows the interests and practical needs of the members.
- We have set up at the end of 2023 a **working group on regional quality schemes**, chaired by Euskadi and moderated by AREPO, whose meetings began in 2024.
- This work has been complemented with an **in-depth study of existing regional public quality schemes** in AREPO regions, carried out with the help of a group of students from the Master Food Identity.
- Working groups are also a useful tool to build up AREPO position on a specific topic. In summer 2022, **AREPO set up a technical working group**, made up of experts from its member regions and members of its Scientific Committee, **to start discussing the main elements of the EC proposal for the GI regulation**, as well as drafting some amendments' proposals.

In June 2023, we launched an internal call for experts to give AREPO members the possibility to follow these meetings. The European Parliament **reacted positively** to our demands.

During past legislature (2019-2024), AREPO established solid relations with several MEPs of the AGRI Committee sensitive to the topic of quality (Clara Aguilera, Eric Andrieu, Isabel Carvalhais, Paolo De Castro, Jérémy Decerle, Herbert Dorfmann, Martin Häusling, Norbert Lins, Anne Sander, Irène Tolleret).

Proof of this solid relationship is the objectives achieved in the revision of the EU Geographical Indications system. In fact, **many of AREPO amendments were included by rapporteur De Castro in his report** (24 out of 50), while 32 of the 122 amendments presented by MEP De Castro **were inspired at least in part by our proposals**.

**Several MEPs** participated in our events, especially in the 5th Edition of the European Event on Quality and Origin Products, organised in the framework of the AGROSMARTglobal project, and in the conference *"The new legal framework for EU Quality Products: opportunities and challenges for mountain and GI products"*, organised in the framework of MOVING project.

Furthermore, **AREPO was a member of the Intergroup on wines, alcoholic beverages and quality food**, chaired by **MEP Irène Tolleret** (Renew Europe).

AREPO Policy Officer, **Francesca Alampi**,

has been appointed as an expert to assist **Ms. Karine Gloanec-Maurin**, the CoR rapporteur for the opinion on the revision of the EU Geographical Indication (GI) system. In this capacity, AREPO supported the rapporteur during meetings with other institutional actors and stakeholders. Additionally, they played a crucial role in the elaboration of the draft opinion, formulating amendment proposals and offering policy recommendations on the European Commission's text. This work was informed by AREPO's internal research and collaboration with other GI stakeholders at the EU level. This opinion was **[unanimously approved by the CoR plenary](#)** at the end of November 2022.

► **European Union Intellectual Property Office (EUIPO)**



Despite defending the importance of maintaining the management of the EU GI system under the DG AGRI of the European Commission, AREPO has actively engaged in an **open dialogue** with EUIPO, with the aim to understand and discuss the competences that EUIPO has developed on GIs as well as its relation with DG AGRI.

We started this dialogue in March 2022, when AREPO organised a **technical meeting with EUIPO** ([click here](#) to read the report), followed by a bilateral meeting between AREPO President, **Ms Begoña García Bernal**, and EUIPO Executive Director, **Mr Christian Archambeau**, to discuss the concerns raised by AREPO on the involvement of EUIPO in the management of the EU GI system.

Since then, AREPO is regularly **invited to participate in the stakeholder public consultation** concerning the update of the Guidelines on Trade Mark Practice and Guidelines on Designs Practice.

**In 2023**, we continued working in order to **strengthen this cooperation**, in particular:

- In March 2023, **EUIPO took part in AREPO conference organised in Brussels** in the framework of the 5th Edition of the European Event on Quality and Origin Products, represented by Ms Katarina Kompari, IP legal specialist.
- On 30 November 2023, we accompanied the CoR's rapporteur on GI review in a **bilateral meeting with new Executive Director Joao Negrão**. This was the occasion to present AREPO and express our interest in strengthening our cooperation, setting up a regular dialogue between AREPO and EUIPO.

## Part 4 | European projects

### I. AGROSMARTglobal | Interreg Sudoe 2014-2020

AGROSMARTglobal was a 3.5-year EU co-funded project that [started in October 2019](#) and [ended in March 2023](#).



The [AGROSMARTglobal project](#) “Space for the competitiveness, promotion and intelligent international expansion of agri-food cooperatives in the Sudoe rural areas” was co-funded by the Interreg Sudoe Programme 2014-2020 under Priority Axis 2: Stimulating the competitiveness and internationalisation of SMEs in South-West Europe.

AREPO's primary objective was [to create a 'best practice' guide](#) tailored for GI consortia, producer associations, and agri-food cooperatives within the EU. This guide is designed to equip them with [practical tools for safeguarding their geographical indications \(GIs\) on the Internet](#). Currently, there is a lack of robust protection for GIs in the realm of domain name allocation. The proposed new approach by ICANN (Internet Corporation for Assigned Names and Numbers) poses a threat to their protection. Safeguarding against internet fraud is crucial in upholding the rights of both producers and consumers.

The University of Trás-os-Montes e Alto Douro (UTAD), with AREPO's assistance, has also been tasked with drawing up a “best practice” guide for GI consortia, producer associations and agri-food cooperatives in the EU, aimed at improving their knowledge on how to promote their products that benefit from EU quality schemes (PDOs, PGIs, TSGs and organic farming) on the Internet, to take better advantage of their added value on international digital markets.

## II. MOVING | Horizon 2020






MOVING | MOUNTAIN Valorisation through INterconnectedness and Green growth was a Horizon 2020 project (2020-2024) coordinated by the University of Córdoba, gathering 23 partner organisations. It ended on the 31 August 2024.

The project intended to build capacities and co-develop policy frameworks across Europe. It established new or upscaled value chains to contribute to the resilience and sustainability of mountain areas to climate change.

The project has rolled-out its research activities and actions engaging relevant stakeholders through Multi-Actor Platforms (MAPs) in 23 mountain regions from 16 countries. These regions represented the wide diversity of mountain areas in Europe and neighbouring countries.

AREPO contributed to this project by involving regional/local authorities and producer associations in the mountain areas of its member Regions, providing its expertise in policy evaluation and its experience in promoting and disseminating the project's results. In particular:

- We participated in the **MOVING Steering Committee meetings** held online and in-presence, to present the progress achieved all along the project and discuss the steps ahead.
- In collaboration with Euromontana, we elaborated, run and analysed a survey **on the implementation of the optional quality term (OQT) mountain product**, addressed to regional authorities and producers. The OQT report is available [here](#). 
- AREPO organised the conference "*The new legal framework for EU Quality Products: opportunities and challenges for mountain and GI products*" (Brussels, 10 April 2024), together with Euromontana and oriGIn EU gathering EU Institutions, Regional governments, Producers of mountain and of GIs products, and EU stakeholders from the agri-food sector, to discuss the new EU legal framework for Quality Products and to present the OQT report.
- AREPO took part in the *Workshop 'Unlocking the Power of Mountain Value Chains'* (Inárcs – Hungary, 6-8 November 2023), intended to foster connections and facilitate knowledge exchange among around 100 mountain representatives spanning 16 countries and 22 diverse mountain ranges. **We facilitated two sessions of the workshop dedicated to Cluster V on Value and quality products**, focused on addressing common challenges and collaboratively developing shared solutions ([find here](#) all MOVING Clusters). 
- AREPO played a pivotal role in drafting a **MOVING report that conducted cross-case comparison and benchmarking** of value chains (VCs) in 23 mountain regions (download it [here](#)). The report analysed their contributions to sustainability and resilience, pinpointing challenges and trade-offs, and proposing solutions. AREPO specifically contributed to the section on **Value and quality products in Cluster V, focusing on VCs under quality schemes**.

- We drafted as well a **Policy Brief** summarising the outcomes of Cluster V (download it [here](#)), emphasising key challenges and elaborating policy recommendations to enhance VCs contribution to sustainability and resilience of mountain areas.

### III. GI SMART | Horizon Europe

The project proposal we actively contributed to for the GI SMART project has been approved by the European Commission and will be funded. This is a Horizon Europe aiming to delve into the topic of the sustainability of geographical indications.

The project began on **1 June 2024** and will last for 4 years.

The GI SMART project will undertake [research and demonstrative activities](#) (innovative pilot actions) and provide [evidence-based recommendations to enhance the contribution of the GI system to sustainable development](#).

Specifically, GI SMART aims to assess and strengthen the contribution of GIs to the Farm to Fork strategy for sustainable food systems in Europe, contributing to:

- improving the understanding of the contribution of GI systems to sustainable development;
- enhancing the perception of GI sustainability by consumers, local communities, and society in general; and
- improving the design and implementation of quality policy to promote the contribution of GIs to sustainable agriculture and fisheries, healthy and sustainable diets, and sustainable food systems.

The **project budget** is approximately **3 million euros**, fully funded (thus no expenses are expected from AREPO, as all activities will be 100% financed).

The **consortium** consists of 17 partners (15 beneficiaries and 2 associated partners), spanning 10 countries. The partners include leading universities, NGOs, and stakeholder organizations in the GI sector, aiming to provide a multi-stakeholder approach to ensure the project's objectives are achieved with maximum impact. The consortium is **coordinated by INRAE**, the French agricultural research institute. Several members of AREPO's scientific committee are involved in the project.

Additionally, AREPO has engaged various partner organizations: Euromontana, oriGIn International, and EFOW.

**AREPO main role will involve leading communication and dissemination work and stakeholder engagement, in collaboration with Euromontana.** Among other tasks, AREPO will be responsible for creating and coordinating a **European multi-actor network of stakeholders from the GI sector** including producers, certification bodies, consumers, and public administrations (at national and regional levels). The aim of the network will be to monitor and contribute to project activities.


